董事會報告

Board of Directors Report

社員數目

截至 2023 年 3 月 31 日止,本社社員數目為 234 名,其中包括 39 家社員儲蓄互助社和 195 名個人社員。本年度共有 1 家社員儲蓄互助社及 14 名個人社員加入本社;另外有 5 名個人社員退出本社。

股份結餘

本社於 2023 年 3 月 31 日的股份結餘為 68,577,618 港元,較上年度減少 27.27%

貸款結餘

截至 2023 年 3 月 31 日止之貸款結餘為 1,131,998 港元,較上年度減少 41%。

資產

淨資產則為 75,580,425 港元,比上年度減少 24.37%。

資產管理服務

2022 年,面對銀行利息不斷攀升而引發的社員 大幅提取股份的挑戰,令致資產管理的工作日 益困難。雖則是次的退股潮可算是近年較大的 挑戰,股份結餘比對上年度下降逾 27%,幸而 本社一直緊守謹慎理財的政策,維持充足的流 動現金,故而可輕鬆面對是次挑戰。

在投資方面,因應市場的動盪情況,我們更加 小心及採取相對保守的策略,以確保社員存放 的資金得到最佳的保障及獲得合理的回報。

在此需要特別多謝協會資產管理委員會的協助 及努力,盡力克服各項挑戰,在 2022 年維持穩 定的收益。

Membership

As at 31 March 2023, the Union had a total of 234 members, including 39 credit unions and 195 individual members. One member credit union and fourteen individual members joined the Union this year. Five individual members quitted the Union.

Share Balance

The share balance as at 31 March 2023 was HK\$68,577,618, showing a decrease of 27.27% when compared with that of previous year.

Loan Balance

As at 31 March 2023, the loan balance was HK\$1,131,998, showing a decrease of 41% when compared with that of previous year.

Asset

The net asset of HK\$75,580,425 showed a decrease of 24.37% when compared with that of previous year.

Asset Management Service

In 2022, the challenge of big share withdrawal due to interest rate hike, makes the asset management works more difficulty. Although the withdrawal of shares was one of the greater challenges in recent years, with the share balance falling by more than 27% compared to the previous year, the Union was fortunate to maintain sufficient cash flow in line with its policy of prudent financial management and was able to face this challenge with ease.

On the investment, we have taken a more cautious and conservative approach in response to the volatile market conditions to ensure the best protection and reasonable returns for the members' savings.

We would like to specially thank the League's Asset Management Committee for their assistance and hard work, endeavour to ride on the challenges and maintained a stable return in 2022.

社員服務

Credit Union Services

In response to the rapid surge in bank interest rates in the market, the Union introduced a Fixed Deposit Scheme to enable members to capture more income immediately. The Board of Directors will continue to maintain policies and services in line with market trends.

The Anti-epidemic Loan Scheme will be ended shortly. As the loan scheme has been well received by many members during the promotion period, the Board will consider extending this type of loan scheme on a regular basis.

Promotion and Member Activities

The HKLCCU's 50th anniversary celebrations have been completed with the successful completion of the Finance Seminar on 29 March 2023.

Last year's 50th anniversary celebrations included the publication of 50th Anniversary Special Issue, a 50th Anniversary Dinner, a Logo Design Competition and a Charity Walk, all of which were successfully completed.

We would like to thank all the members for their support and participation, and all our committee members and staff for their efforts and assistance.

Dividend on Shares

We will announce the dividend rate recommended by Board afterwards. With approval of the Meeting, dividend will be paid on all shares fully paid up as at 31 March 2023.

The Future

In the coming year, besides carrying out our investment with due consideration, we will also support the League including financial support to sustain and promote the Hong Kong credit union movement.





Investments

2022/23 was a very difficult year for Credit Unions. The unprecedented interest rate hikes by the US Federal Reserve drove up the world bank interest. All CUs have to face ruthless withdrawal from members for higher rate bank fixed deposits. The HKLCCU Board reacted by lowering the expenses and selling investment items to prepare for the expected large withdrawals. Meanwhile our Assets management team also launched the Fixed Deposits scheme as a service for members to enhance their income.

Undivided Earnings Available for Appropriation

Prospect

Without exception, our share dropped significantly over 27%. Yet our investment & deposits returns are stable thus this year's dividend can still go up. In light of the high bank interest rate, besides keeping with our usual stable investment strategy, we would continue with the fixed deposit scheme to enhance members' income. We thank you for your continuous support in future, esp. those members who trust us in this difficult period.

帳項附註

Notes to the Accounts

1. 會計帳項編製準則

此會計帳項的編製準則是根據原始成本 方式、香港會計師公會所頒佈的會計實務 準則及詮釋、香港公認會計原則、並符合 《儲蓄互助社條例》及香港協會中央儲蓄 互助社章程。

2. 主要會計政策

2.1 收入的確認

社員貸款利息收入是以實際已收的 利息入帳。於年結月時,當月的應收 社員貸款利息收入均於應計之時在 收支表內確認。

存款利息和投資收入均於應計之時 在收支表內確認

- 2.2 投資證券
- 2.2.1「持有至到期日證券」為預算持有至 指定贖回日期的證券,並以帳面價值 及以每項投資項目獨立計算。當投資 的帳面價值不能收回時,以贖回時的 淨實收款項與證券的帳面價值的差 額,在收支表內確認。
- 2.2.2.其他投資證券會被列為「其他投資」,並以帳面值列出。出售投資證券的盈利或虧損,以出售時的淨實收款項與證券的帳面價值的差額,在收支表內確認。
- 2.2.3 所有香港股票會被列為短期投資, 並以帳面值列出。出售香港股票的 盈利或虧損,以出售時的淨實收款 項與股票的帳面價值的差額,在收 支表內確認。

2.3 外幣

以非港元之外幣為單位之貨幣資產 及負債均按年結日之匯率再折算為 港元。因匯兌而產生之權益及虧損均 撥入收支表處理。

Basis of Preparation of Accounts

The accounts are prepared under historical cost convention and in accordance with applicable Statements of Standard Accounting Practice and Interpretation issued by the Hong Kong Society of Accountants, accounting principles generally accepted in Hong Kong and the requirements of "Credit Unions Ordinance" and the By-Laws of Hong Kong League Central Credit Union.

Significant Accounting Polices

Income Recognition Interest income on loans is accounted for on cash basis. At the year-end month, interest income on loans is recognised in the Income and Expenditure Statement as they accrue.

Interest on deposits and income from investments are recognised in the Income and Expenditure Statement as they accrue.

Investment Securities

"Held-to-maturity securities" are securities redeemable at fixed dates, intended to be held to maturity and are stated at carrying value, on an individual investment basis. Provisions are made when it is not likely that the carrying value of the investments can be recovered and the difference between the net disposal proceeds and the carrying amount of the investments and are accounted for in the Income and Expenditure Statement they arise.

Other investment securities are classified as "other investments" and are stated at carrying value. Profit or loss on disposal of investments in securities are determined as the difference between the net disposal proceeds and the carrying amount of the investments and are accounted for in the Income and Expenditure Statement they arise.

All Hong Kong stocks are classified as "Short-term Investments" and are stated at carrying value. Profit or loss on disposal of investments in stocks are determined as the difference between the net disposal proceeds and the carrying amount of the stocks and are accounted for in the Income and Expenditure Statement they arise.

Foreign Currencies

Monetary assets and liabilities denominated in foreign currencies other than Hong Kong Dollars are re-translated into Hong Kong Dollars at the rates ruling on the balance sheet date. Gains and looses arising on exchange are dealt with in the Income and Expenditure Statement as incurred.




